

HOLIDAY PASSPORT SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

Eligibility: Holiday Passport Sweepstakes ("Sweepstakes") is open only to legal residents of, and physically located within, the fifty (50) United States or the District of Columbia, age eighteen (18) years or older at time of entry.
